The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Felony Receiving Stolen Property

Minnesota Statute: 609.53.1, with reference to: 609.52.3(3)(a)

Maximum Sentence: Five (5) years and/or \$10,000

Offense Level: Felony

Offense Date (on or about): 07/24/2019 to 08/07/2019

Control #(ICR#): 19127431

Charge Description: That the Defendant, KEITH BRIAN BOSHEY, JR., did receive, possess, transfer, buy or conceal stolen property or property obtained by robbery, knowing or having reason to know the property was so obtained, said property having a value greater than \$1,000 but not more than \$5,000.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

IBetween July 24 of 2019 and August 7 of 2019, investigators from the Lake Superior Drug and Violent Crime Task Force conducted several controlled purchases of stolen bicycles in the City of Duluth, St. Louis County, Minnesota, from KEITH BRIAN BOSHEY, JR., dob 06/17/1990, hereinafter Defendant. Each of the bicycles during the controlled buys had been reported stolen. The value of three of the bicycles that were purchased during the controlled buys value after consultation with a local bicycle retailer are in excess of \$1,500. The Defendant had been selling bicycles over the Facebook online sales platform. On August 7, 2019, investigators from the Lake Superior Drug and Violent Crime Task Force executed a search warrant at the Defendant's residence after the Defendant met with law enforcement to complete a fourth controlled buy of a bicycle. At that time, law enforcement took custody of the fourth bicycle which the Defendant had arranged with the undercover officer to sell. An additional five bicycles were recovered during the execution of the search warrant.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
